With COVID-19 restrictions in place, obtaining an electronic signature seemed like an easy alternative, and technically speaking, it was. Yet

after three days of back-and-forth questions through voice mail, email and texts, my document remained unsigned. So much for technology making it easier for people to connect.

If COVID-19 taught us anything positive, it's that taking personal and professional connections for granted does not serve us well. ### **Understanding the Future of CPA Licensure**

The <u>CPA profession is always moving forward</u>, adopting new technologies, new skills, and new best practices. The job requirements of most CPAs today are completely different from those of a CPA even 20 years ago. As the profession evolves, so must the steps to licensure.

The American Institute of CPAs (AICPA) and the National Association of State Boards of Accountancy (NASBA) are in the process of updating and restructuring the CPA Exam to align with the skillsets needed of newly licensed CPAs (nlCPAs). They recently agreed to move forward with the CPA Evolution initiative and timeline and are working to have the new exam ready to roll out to CPA candidates by January 2024. Since the CPA Evolution initiative is aimed at evolving CPA licensure to reflect the skills and knowledge CPAs increasingly need in a technology-driven marketplace, future CPAs will have different concentrated areas than was presented before. The following is a quick breakdown of the future CPA licensure model to help you understand what will be expected of our future CPAs.

#### **Core Skills**

At the heart of the CPA Evolution is a core mastery of accounting, auditing, tax, and technology. These core skills maintain the same standard principles that CPAs of the past have mastered but place a new emphasis on the technological requirements of the modern CPA profession. To be clear, the new licensure model requires the same mastery of accounting, auditing, and tax that have been staples of the CPA Exam. There is simply an added requirement that a modern CPA be versed in the modern technologies of the industry.

#### Disciplines

The CPA Evolution requires that every candidate choose one discipline in which to specialize. The disciplines are currently expected to be: Business Analysis and Reporting, Tax Compliance and Planning, and Information Systems and Controls.

The disciplines allow students to prove a deeper level of understanding of a more specific aspect of accounting without confining them to a career in only that specific area. Regardless of the discipline chosen, the result is the same full CPA Licensure.

#### Structure

The new exam will consist of three core sections and three discipline sections. To earn their licensure, candidates will have to pass all three core sections as well as one discipline section. The exam is expected to remain in the four sections, 16-hour format.

#### Why Change?

Today's CPAs are required to perform more advanced tasks and contribute to increasingly complex projects earlier on in their accounting careers. The CPA Exam must remain relevant as a measure of the knowledge and skills CPAs must have in order to practice their profession as efficiently and effectively as possible.

### Shake Up Your CPE: Five Reasons for CPAs to Consider Moving Outside Their Lane with Continuing Professional Education

Around the world, credentialed professionals of all stripes roll their eyes and sigh when they realize it's time to complete the CPE credits required to maintain their licenses. *Boring!*, they think. *Redundant!* – even worse. *Waste of time!* – ugh.

If these thoughts cross your mind as you come up on your CPE anniversary, perhaps it's time to consider exploring content areas outside of those that align with your specific field of study. If your state's Board of Accountancy allows such flexibility in earning CPE credits, broadening your skills and knowledge in this way brings many benefits. Whether you specialize in auditing and choose to learn more about information technology, or if you specialize in government accounting and opt to dive in to a communications class, you'll emerge a more effective and valuable professional because of it. Here are five reasons why.

#### **Protect Your Brain**

A landmark <u>Mayo Clinic Study</u> found that lifelong intellectual enrichment plays a powerful role in protecting the brain against age-related cognitive decline and dementia. Challenging yourself by tackling a subject matter that is entirely new to you provides the type of intellectual stimulus that can help keep your brain healthy and delay the cognitive impact of aging. And it's never too early (or too late) to adopt a prevention mindset when it comes to one's health.

#### **Build Empathy**

Tackling education topics outside of your primary focus helps you to better understand and relate to colleagues whose fields may otherwise look like voodoo magic to you. Routing that exploration through your CPE requirements kills two birds with one stone: maintaining your current credentials while dabbling in a new area that may present more career fulfillment down the road.

### Bankruptcies in Texas within the Oil & Gas Industry: CPAs Readiness


A wave of bankruptcies grew in 2020 in the Oil & Gas sector driven by the difficulties posed last year on oil price and demand. And although the industry has experienced crises in the past, the full impact of the current unmatched crisis are yet to be seen. Given this context, some thoughts are shared for CPAs serving companies in this industry since they will likely be consulted for advice.

#### Unprecedented Demand Downfall

The Oil and Gas sector has gone through price volatility in the past. Just for reference, between mid-2014 and early 2016, there was a historical oil price decline, among the largest in modern history. The drivers for the crises can be found mainly in the oversupply of shale oil (thanks to "fracking" technology), geopolitical rivalries amongst oil-producing nations (OPEC targeting at lower prices to reduce shale oil production profitability), falling demand (Chinese economy deceleration), and potential limitation of future demand based on environmental policies (2016 Paris Climate Accords). As a result, prices crashed from above \$114 per barrel in 2014 to about \$27 in 2016.

Nevertheless, recent events makes the price decline unparalleled. In March 2020, an oil price war triggered by geopolitical rivalries paired with a historical demand downfall originated by the Covid-19 worldwide impact and its drastic change in consumer behavior, drove the world into an unprecedented situation. As shown in the chart, the West Texas Intermediate price dipped below zero in April for the first time in history.

A depressed economy with a deeply affected oil industry has critically affected Oil & Gas Companies.



#### Difficult Times for Companies in the Oil Industry

The International Energy Agency (IEA) described back in April that the global oil industry is experiencing a shock like no other in the past. A major US law firm has released in Sep 30, 2020 the statistics of producers who have filed for bankruptcy. They indicate that for Exploration and Production (E&P) companies, in the third quarter of 2020, 17 producers filed for bankruptcy. This number, combined with the rest of the filings earlier this year, represents a 21% increase versus prior year. In the aforementioned report, combining the E&P, midstream and oilfield services companies since 2015 to 2020 the total of bankruptcy filings in Texas has been so far 269 (see chart on page 10).



As of mid-2020, the total number of filings in for the energy sector to get protection from creditors was the second-highest after the retail and entertainment industry. And at this pace, without a continued recovery in the oil price an increase would be expected. Rystad Energy indicated that the number of Chapter 11 filings in 2020 has not yet surpassed those of 2016. However, the debt being carried by these companies is higher (19 billion more than 2016). Also, it is expected that a number of small and mid-size producers which are experiencing financial challenges might face an extremely hard situation in order to service their debt in the upcoming years.

#### CPAs sought for advice

A recovery in the Oil and Gas industry does not seem to be appearing on the horizon any time soon. The final outcome and its timing is dependent upon the world's energy demand, clearly tied to the pandemic present situation and future evolution. Therefore, in the upcoming months, companies and individuals whose activities are tied to the oil and gas industry might confront stressful situations and CPAs working with them will likely be consulted for guidance.

The Journal of Accountancy recently published key aspects for CPAs to consider to better deal with companies facing bankruptcy. Among the main things to consider are:

- Steps if a customer may be bankrupt: if there is no blanket purchase or contract order, can switch to cash on delivery, cash before shipment or cash in advance; request a signed financial statement regarding the customer's finances which if false can allow claims of fraud; if a debtor receives goods before filing for bankruptcy, the debt owed for them may be eligible for priority (does not ensure actual or timely payment)
- Will a business liquidating its assets file for bankruptcy? A business ceasing operations and liquidating its assets will likely address its secured creditors outside of the bankruptcy process (which has high filing costs); inability to pay creditors does not necessarily require to file a bankruptcy petition
- Can a financially stressed company continue payments to suppliers while not paying sales tax or payroll taxes? Nonpayment can lead to personal civil or criminal liability due to failure to remit withheld taxes to the government; CPAs making payment decisions while managing a tight cash flow are candidates for penalties.
- CPAs are asked for advice on prioritizing obligations: great care must be taken when deciding whom to pay; some considerations: (a) timing, since payments made on old debt too close to a bankruptcy filing may be overturned as a preference and (b) types of debt, like non-dischargeable (will survive a bankruptcy proceeding)

In addition, recent changes to the bankruptcy process need to be considered like the Small Business Reorganization Act of 2019 which introduced the new option called Subchapter V for Chapter 11 bankruptcies. Also, the CARES Act brought several changes to Chapter 11 reorganizations of small business debtors and updates to Chapter 7 and Chapter 13 of the Bankruptcy Code.

To help clients who are considering bankruptcy it is critical to analyze all viable alternatives. Good advice would be to suggest creating a plan since filing for bankruptcy without a developed plan and hoping problems will go away would actually be counterproductive due to potential unintentional effects that can be triggered by the filing. Furthermore, key guidance would be to advocate for getting help from knowledgeable, responsible professionals to make the right decisions.

Although specialized CPAs and professionals focused on reorganizations or asset liquidation working with legal counsel may conduct and lead this difficult situation, the relationship that CPAs currently have with their clients can prove valuable through explaining the basic concepts of bankruptcy.

### **The Future of Your Profession - Support Accounting Scholarships**

Since the TXCPA Houston Accounting Scholarship Program's 2004 inception, 432 scholarships, exceeding a total of \$1,450,000 have been provided to aid university students in completing their accounting degree. Many of these students are now the CPAs working in your firm or accounting department.

2004 - Accounting Scholarships Committee was established to award scholarships annually to accounting majors in need of financial assistance to complete the 150-hour requirement to sit for the Texas CPA Exam.

2005 – Eight \$1,000 scholarships were awarded to local students.

2006 – Accounting Scholarships Programs became a beneficiary of the annual charity event, now renamed the Scholarship Extravaganza, and ten \$3,500 scholarships were awarded.

Many accounting scholarship recipients are firstgeneration college students. Most cannot rely on financial assistance from their families, and that will be as true, if not more so in 2021. Due to the pandemic, many workers remain out-of-work due to hotel, restaurant, and other service industry closures and downsizing. Your support is critical during this time. The \$3,500 scholarship for a student to complete their 150 required hours is critical to the future CPA who becomes your employee or team member in a few years.

Some TXCPA Houston board members, and committee leaders, are prior recipients of these scholarships that helped them fulfill their dream of becoming a CPA! Accounting Scholarship applications are reviewed by multiple committee members, discussed at length, and distributed to those students with the greatest financial burden. All applicants must possess at least a 3.0 overall GPA and a 3.25 accounting GPA.

Eligible applicants should be a full-time student at a local TXCPA Houston membership area university:

- Houston Baptist University
- Prairie View A & M University
- Rice University
- Sam Houston State University
- Texas Southern University
- University of Houston
- University of Houston Clear Lake
- University of Houston Downtown
- University of St. Thomas

Scholarships of \$500 are available for accounting students in the local educational systems of Houston Community College or Lone Star.

### **CPAs Helping Schools**

CPAs Helping Schools virtual Partners in Education reception was held on January 14 and attended by committee members and Chapter leadership. Ten educators from the five schools talked about their programs that the CPAs Helping Schools grant initiative is funding.

The TXCPA Houston CPAs Helping Schools Committee awards up to \$50,000 annually in financial grants to Houston area schools for educational projects benefiting at-risk students.

There were fewer grant applications received in 2020, due to COVID-19 and changes to offer virtual learning. Additionally, the uncertainty of campus education in the fall semester, and the COVID-19 impact on the local education system, caused the committee to defer all decisions until the fall review period. Committee members considered seven requests, mostly for Science, Technology, Engineering, and Math (STEM) programs.

Member expressed concerns over sanitization procedures for the materials and the actual number of students in the physical classroom, which were answered by the grant writers prior to funding approval.

Since the formal grant process began in 2002:

- Over 600 grant applications were reviewed,
- Over \$550,000 was awarded,
- To over 200 schools,
- In 35 local districts, and private, parochial schools and nonprofit educational organizations.

In addition to providing education basics for at-risk youth, the financial support continues to establish initiatives including math, technology, and literacy programs, library improvements, science materials, resources for after-school programs, fine art programs and health awareness.

CPAs Helping Schools can help the scores of local schools with such a variety of programs, thanks to 1) your **generous financial support** and 2) the magnificent group of **volunteers** that donate two hours at each grant meeting to participate and make the required decisions.

#### In this new year, the committee needs more of both!


The committee continually looks at rebuilding their coffers to enable them to assist the many schools in need that request financial and volunteer assistance with their educational projects, which encourage education and academic excellence in students of all ages.

**THANK YOU** for your past contributions, either through voluntary contributions or through financial support of our Scholarship Extravaganza. A portion of all net proceeds of this annual event went to the grant program through 2020.

In 2021, CPAs Helping Schools is seeking new capital from private and corporate foundations to provide funding in support of the grant program, originally endowed in 1996 with a mission to provide educational resources to at-risk youth.


