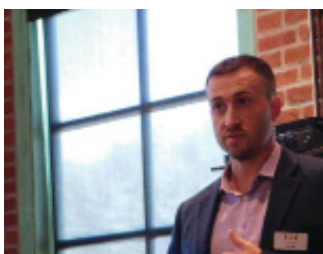

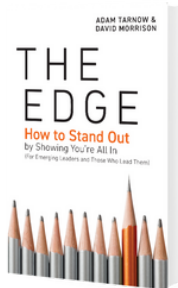
# LEADERSHIP DEVELOPMENT ACADEMY
