Events

TXCPA Corpus Christi offers seven luncheon programs and a one-day Annual Tax Conference each year.

Continuing Education Luncheons

Continuing education luncheons through the end of the 2020 calendar year will be held virtually. If possible, luncheons will be held in person starting in January and be held The Texas State Aquarium. All programs are held from noon to 1:00 p.m. Luncheons have an average attendance of 45 people for each program. The 2020-2021 schedule is as follows: September 18, 2020, October 23, 2020, November 20, 2020, January 22, 2021, February 19, 2021, March 26, 2021, and May 21, 2021.

The luncheon program includes 10 minutes of announcements and chapter business followed by a 50-minute continuing education presentation from an outside speaker.

Promotion of luncheon events is sent to all chapter members via email (approximately 400 recipients), promoted on the chapter's social media channels, and shared with the *Corpus Christi Caller-Times* for inclusion on the Business Datebook.

Annual Tax Conference

TXCPA Corpus Christi's Annual Tax Conference is scheduled for Friday, February 5, 2021 at the Region 2 Education Service Center. The tax conference has an average attendance of 150 people each year.

The conference program includes nine hours of continuing education sessions.

Promotion of the Annual Tax Conference is sent via email to TXCPA CC members, as well as TXCPA CPA members in Victoria, Laredo, and the Rio Grande Valley (approximately 800 recipients), promoted on the chapter's social media channels, and shared with the *Corpus Christi Caller-Times* for inclusion on the Business Datebook.
